

FOR INSURING THAT ALL MATERIAL, INSTALLATION, AND TESTING MEET THE APPROVAL

FOR INSURING THAT ALL MATERIAL, INSTALLATION, AND TESTING MEET THE APPROVAL WATER LINES SHALL BE PRESSURE TESTED AND DISINFECTED AS REQUIRED. PROVIDE AS BUILT DRAWINGS TO THE PORPER AUTHORITIES AND THE ENGINEER.

4. THE LEXINGTON PUBLIC UTILITIES DEPARTMENT SHALL BE NOTIFIED 24 HOURS PRIOR TO ANY WATER OR SEWER LINE CONSTRUCTION OR

ALL WATER MAIN AND SANITARY SEWER MATERIALS AND WORKMANSHIP SHALL BE IN ACCORDANCE WITH THE UTILITIES PROVIDER'S "STANDARD SPECIFICATIONS FOR CONSTRUCTION OF WATER MAINS AND SANITARY

SET OF DESIGN DRAWING SHOWING ALL "AS BUILT" CONDITIONS. THESE "RECORD DRAWING" SHALL BE MADE AVAILABLE TO THE DESIGNER AND/OR THE CITY INSPECTOR UPON REQUEST. THE MARK-UPS SHALL BE AT THE SITE AT ALL TIMES AND SHALL BE UTILIZED TO DEVELOP FINAL RECORD DRAWINGS.

9. BASED UPON INFORMATION FURNISHED OWNER, CONDITIONS AT EXISTING WATER MAIN PROVIDE APPROX 70 TO 80 PSI.

10. PROVIDE ONE HOSE BIB AT THE FRONT SIDE OF EACH BUILDING

1. CONTRACTOR SHALL PAY FOR ALL TAP FEES, LICENSEES, AND IMPACT FEES,

2. ALL SEWER LINE SHALL BE INSTALLED AS INDICATED. ALL SEWER LINE WORK SHALL COMPLY WITH ALL LOCAL AND STATE CODES. CONTRACTOR SHALL BE RESPONSIBLE OF THE LOCAL AND STATE AUTHORITIES. PROVIDE AS BUILT DRAWINGS TO THE PORPER AUTHORITIES AND THE ENGINEER.

3. ALL WATER LINE SHALL BE INSTALLED AS INDICATED. ALL WATER LINE WORK SHALL COMPLY WITH ALL LOCAL AND STATE CODES. CONTRACTOR SHALL BE RESPONSIBLE OF THE LOCAL AND STATE AUTHORITIES.


6. THE CONTRACTOR SHALL BE RESPONSIBLE FOR MAINTAINING A MARKED-UP

7. MINIMUM HORIZONTAL DISTANCE BETWEEN WATER AND SEWER LINES SHALL BE 10'-0" AND VERTICAL SEPARATION SHALL BE 18"

8. WHERE WATER AND SEWER LINE CROSS THE WATER SHALL BE 18" ABOVE THE SEWER LINE. IF THE SEWER MUST BE ABOVE THE WATER LINE, IT SHALL BE 18" ABOVE AND ENCASED IN CONCRETE A MINIMUN OF 10'-0" ON EACH SIDE OF SEWER LINE.
